Professional Summary

I am a political economist specializing in housing markets and fiscal policy, researching how taxation, regulatory design, and institutional quality shape residential mobility, price dynamics, and market stability. My work combines causal inference with novel measurement techniques to evaluate policies (e.g., property taxation) across the US, UK, and Sweden. I develop composite indices and statistical frameworks to quantify market conditions and institutional environments with greater precision than existing approaches, producing empirically rigorous, policy-relevant analysis at the intersection of politics, economics, and law.
